

Share buyback transaction details

Sligro Food Group N.V. ('Sligro') reports that it has repurchased 46,511 of its own ordinary shares in the period from 14 September up to and including 18 September 2026, for € 475,697,19 and at an average share price of € 10.2276

These repurchases are part of the share buyback programme announced on 23 July 2026, under which we intend to repurchase shares for an amount of up to €13 million, to be executed between 24 July 2026 and 3 February 2027 (the 'Programme').

The cumulative amounts repurchased to date under the Programme are as follows:

Sligro has appointed an independent broker to execute the Programme, under the authority to purchase up to 1,106,375 shares, representing 2,5% of Sligro's issued share capital. The exact timing of the purchases will be determined by this broker independently and without interference from Sligro. The Programme will be carried out in compliance with the requirements set out in article 5 of the Market Abuse Regulation (EU) No 596/2014 and our articles of association. The execution of the Programme is dependent on market conditions and may be suspended, modified or discontinued at any time. Shares repurchased under the Programme will be cancelled.
